1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Application of Part II of Sheep Scab Order of 1928.

- 1.—(1) Part II (Restriction on Movement of Sheep out of a Movement Area) of the Sheep Scab Order of 1928, hereinafter referred to as the principal Order, is hereby applied to the Area described in the Schedule hereto, which shall be a Movement Area for the purposes of that Order.
- (2) This Article shall come into operation on the first day of June, nineteen hundred and twenty-nine, and shall cease to operate on the thirty-first day of July, nineteen hundred and twenty-nine.

Application of Part III of Sheep Scab Order of 1928.

2. Part III (Double Dipping of Sheep in a Double Dipping Area) of the principal Order is also hereby applied to the Area described in the Schedule hereto, which shall be also a Double Dipping Area for the purposes of that Order:

Period Prescribed as Double Dipping Period.

3. The dates between which all sheep in the Area described in the Schedule hereto are to be dipped within the Area by the owner or person in charge of the sheep under and in accordance with Part III of the principal Order, are hereby fixed to be the thirty-first day of May, and the first day of August, nineteen hundred and twenty-nine.

Revocation of certain Order.

4. The Order of the Minister (No. 4733) dated the eighteenth day of April, nineteen hundred and twenty-nine is hereby revoked.
