form of gas shall be substituted therefor; (b) the statutory or other provisions affecting the charge which the Corporation may make in the added limits shall be modified by substituting from and after the final reading of the consumers' meters in the quarter ending immediately thereafter for the said maximum price per thousand cubic feet a maximum price per therm (i.e. 100,000 British Thermal Units) of one shilling and four decimal four pence per therm and that within such maximum the Corporation may charge a price in the added limits not exceeding two decimal four pence per therm above the price charged for gas within the city of Coventry; (c) the gas to be supplied thereafter in the added limits shall be of a calorific value of not less than 480 British Thermal Units or such other value as may from time to time be declared in accordance with the provisions of the Coventry Corporation Act, 1927, relating to the variation of the declared calorific value of the gas supplied by the Corporation; (d) the provisions of the said Act relating to the declaration of calorific value, the variation of declared calorific value, pressure and testing of gas and application of the Gas Regulation Act, 1920, shall extend and apply to the added limits.

7. To provide that the charge for the hire of a prepayment meter and fittings in the added limits, when gas is supplied from the Corporation's gasworks at Foleshill, shall not exceed, for a prepayment meter and fittings (including a cooking stove) three decimal six pence per therm, for a prepayment meter and fittings (not including a cooking stove), three pence per therm, and for a prepayment meter without fittings a rate of ten per centum per annum on the cost of the meter.

8. To enable the Corporation or the said Company to borrow money for the costs of the Order, for the purchase of the undertaking of the above-mentioned Company, for the construction of a main to connect the Corporation's gas works with the gas works of the Company, and generally for the purposes of their gas undertaking and to make provision with regard to the repayment of the moneys

so borrowed, and to make other financial pro-

visions.

9. To incorporate and apply with or without modification all or some of the provisions of the Lands Clauses Acts, the Gasworks Clauses Acts, 1847 and 1871, the Public Health Act, 1875, and any Acts amending the same, and the Local Loans Act, 1875, and to repeal, alter, amend or re-enact all or any of the provisions of the Bedworth Gas Order, 1899 (confirmed by the Gas Orders Confirmation (No. 1) Act, 1899), and of any Act or Order relating to the Gas Undertaking of the Corporation or the said Company.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the draft Order, may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the 27th day of May, 1929. Any such objection shall state:—

- (a) the specific grounds of objection; and
- (b) the omissions, additions or modifica-

Copies of the draft Order, and of an ordnance map on a scale of one inch to the mile, showing the situation of the existing gasworks of the Corporation and of the Company, and the boundaries of the existing limits of supply of the Corporation and of the added limits have been deposited for public inspection at the offices of the undermentioned Town Clerk in the Council House, Coventry, and with the Clerk of the Peace for the County of Warwick at his office at Leamington.

NOTICE is hereby given that James Lewis Hamilton Williams of Market Square Narberth in the County of Pembroke (hereinafter called "the Undertaker") has applied to the Electricity Commissioners under the Electricity (Supply) Acts, 1882 to 1926, for a Special Order (hereinafter called "the Order") for all or some of the following purposes (that is to say):—

To prescribe the maximum price or maximum prices that may be demanded and taken by the Undertaker in respect of the supply of electrical energy.
