DANGEROUS DRUGS ACTS, 1920-1925.
WITHDRAWAL OF AUTHORITY (JAMES SCOTT WEBSTER).

Whereas James Scott Webster, M.B., Ch.B., Ed., 82, Romford Road, Stratford, London, E. (lately resident at "Alma," Drumoak, Aberdeenshire), has been convicted of an offence against the Dangerous Drugs Acts:

And whereas the said James Scott Webster cannot, in my opinion, properly be allowed to be in possession of or to supply any of the drugs or preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

Now, therefore, in pursuance of the powers conferred on me by Regulation 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by Regulation 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, I hereby give notice that I withdraw, as from to-day's date, from the said James Scott Webster, the authority granted by the said Regulations to duly qualified medical practitioners to be in possession of and supply raw opium, coca leaves and Indian hemp, and the drugs and preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

And I also direct, as from the same date, that it shall not be lawful for the said James Scott Webster to give prescriptions for the purposes of the Dangerous Drugs (Consolidation) Regulations, 1928.

Sixteen Hackney Carriages:

In Two Portions.

First Portion. At Berners Street, four carriages in centre of roadway, commencing at a point fifteen feet from the Southern building line of Eastcastle Street and extending Southward as far as necessary for four carriages.
Front of vehicles toward the North.

Second Portion. At Eastcastle Street, twelve carriages in centre of roadway, commencing at a point fifteen feet from the Eastern building line of Berners Street and extending Eastward as far as necessary for twelve carriages.
Front of vehicles toward the West.

The first portion of the Standing to be fed exclusively by carriages from the second portion.
