And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Coventry has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas no appeal has been made to His Majesty in Council within the period of one month after the date of the said public notice in accordance with the provisions of the said Measure against the said Scheme or any part thereof by any person who has made objection as aforesaid to the said draft Scheme:

And whereas the said Scheme has been approved at the Council held under the authomits of the said Scheme

WHEREAS His Majesty was pleased by His Commission dated the 4th day of December, 1928, to nominate and appoint Her Majesty The Queen, His Royal Highness The Prince of Wales, K.G., K.T., K.P., G.C.S.I., G.C.M.G., G.C.I.E., G.C.V.O., G.B.E., His Royal Highness The Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., the Most Reverend Father in God Cosmo Gordon, Archbishop of Canterbury, the Right Honourable Douglas McGarel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy Council, and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, and of the Act of the 3rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and of the Act of the 3rst and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 14th day of March, 1929, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, and of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113; the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and of the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council the following Scheme for effecting (1) the union of the Benefice (being a Vicarage) of Overton with Fyfield and the Benefice of East Kennett (now part of the United Benefice of Avebury with East Kennett), (2) the union of the Benefice of Avebury (being the remaining part of the said United Benefice of Avebury with East Kennett) and the Benefice of Winterbourne Monkton (now part of the United Benefice of Winterbourne Monkton with Berwick Bassett), and (3) the union of the Benefice of Berwick Bassett (being the remaining portion of the said United Benefice of Winterbourne Monkton with Berwick Bassett) and the Benefice (being a Rectory) of Winterbourne Bassett all of which Benefices are situate in the County of Wilts and in the Diocese of Salisbury:

"Whereas Commissioners appointed at our request by the Right Reverend St. Clair George Alfred, Bishop of Salisbury, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report (inter alia) upon the unions of the said Benefices (1) of Overton with Fyfield and East Kennett (2) of Avebury and Winterbourne Monkton, and (3) of Berwick Bassett and Winterbourne Bassett duly made their Report to the said Bishop of Salisbury and therein recommended the said unions of Benefices and the terms for effecting the same, and the said
