

CENTRAL CHANCERY OF THE ORDERS
OF KNIGHTHOOD.

The KING has directed that the appointment of Edward Albert Rix to be a Member of the Civil Division of the Most Excellent Order of the British Empire, dated the 5th June, 1926, shall be cancelled and annulled, and his name erased from the Register, in consequence of his having been convicted by the Civil Power.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 31st May, 1929, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £45,000,000.

2. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday, the 3rd June, 1929, to Saturday, the 8th June, 1929, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

CHATHAM AND SHEERNESS STIPENDIARY

Order of the Secretary of State under Section 1 of the Chatham and Sheerness Stipendiary Magistrate Act, 1929 (19 & 20 Geo. 5, c. 50).

Whereas by Section 1 of the Chatham and Sheerness Stipendiary Magistrate Act, 1929, it

is provided that the provisions set out in the schedule to the Act shall have effect as from the day on which the Secretary of State by Order declares that the office of stipendiary magistrate for Chatham and Sheerness will become vacant:

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts of women of 18 and young persons of 16 years of age and over in all Departments (except the Engineers Department) at the works of The British Goodrich Rubber Company Limited, Leyland, Lancashire, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks; that suitable protective clothing where required owing to the nature of the work, cloakroom and messroom accommodation, washing facilities and facilities for sitting shall be provided, and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.
