

## LEEK FAIRS.

## ALTERATION OF DATES.

Whereas a representation has been duly made to me as Secretary of State for the Home Department by the Leek Urban District Council that Fairs have been annually held in Leek on the 13th November and on the Wednesday next after Christmas Day (or on the 26th December if Christmas Day falls on a Wednesday) and that it would be for the convenience and advantage of the public that such Fairs should in future be held on the Wednesday next after the 9th November and on the Wednesday immediately preceding Christmas Day in each year respectively:

And whereas notice of the said representation and of the time when I should take the same into consideration has been duly published in pursuance of the Fairs Act, 1873:

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fairs should in future be held on the Wednesday next after the 9th November and on the Wednesday immediately preceding Christmas Day respectively:

Now therefore I, as Secretary of State for the Home Department, in exercise of the powers vested in me by the Fairs Act, 1873, do hereby order that the aforesaid Fairs annually held in Leek shall in future be held on the Wednesday next after the 9th November and on the Wednesday immediately preceding Christmas Day in each year respectively.

## MONMOUTH FAIR.

The Secretary of State for the Home Department hereby gives notice that by Memorial dated the 23rd May, 1929, a representation has been duly made to him by the Corporation of the Borough of Monmouth that a Fair has been annually held in Monmouth on the 22nd November, and that it would be for the convenience and advantage of the Public that the date on which such Fair is held should be the Monday in the month of November on which the second November Stock Market is held in Monmouth. On the 2nd day of July, 1929, the Secretary of State will take such representation into consideration, and any person who may desire to object to the alteration of the date of the Fair should intimate his objections to the Secretary of State before that day.

and young persons of 16 years of age and over in the manufacture of wall ties from scrap metal at the Stranton Works of The Expanded Metal Company Limited, Greatham Street, West Hartlepool, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable cloakroom and messroom accommodation and washing facilities shall be provided.
