

I hereby order that the Administrative County of Bedford shall be divided for all purposes relating to Coroners into two districts which shall be known as the West District and the North, East and South District respectively, and that such Coroners' Districts shall be constituted as shown in the Schedule hereto annexed:

Provided that if the Chalgrave and Hockliffe Order, 1929, made by the County Council of Bedford, shall be confirmed by the Minister of Health, any reference in the Schedule to this Order to the Parish of Chalgrave or the Parish of Hockliffe shall, as from the day on which the Order of the County Council comes into operation, be read as a reference to that parish as altered by that Order.

This Order may be cited as the County of Bedford (Coroners Districts) Order, 1929, and shall come into effect on the twelfth day of June, 1929.
