Blackburn and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Percy Mark, Bishop of Blackburn, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased hereby to ratify the said Scheme, and to order, as it is hereby ordered, that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Blackburn.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 30th day of May, 1929, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the unions (1) of the Benefice (being a Vicarage) of Norwich, Saint John, Timberhill, with the Benefice (being part of the United Benefice of Norwich, All Saints, with Norwich, Saint Julian) of Norwich, All Saints, and (2) of the Benefice (being a Vicarage) of Norwich, Saint Peter, Parmentergate, with the Benefice (being part of the said United Benefice of Norwich, All Saints, with Norwich, Saint Julian) of Norwich, Saint Julian, all of which Benefices are situate in the County of Norfolk and in the Diocese of Norwich:

"Whereas Commissioners appointed at our request by the Right Reverend Bertram, Bishop of Norwich, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the unions of the said Benefices of Norwich, Saint John, Timberhill, and Norwich, All Saints, and the said Benefices of Norwich, Saint Peter, Parmentergate, and Norwich, Saint Julian, duly made their Report to the said Bishop of Norwich and therein recommended the said unions and the terms for effecting the same,

and the said Bishop of Norwich signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said unions of Benefices based upon the terms recommended in the said Report:

"And whereas the said Benefice of Norwich, Saint John, Timberhill, and the said United Benefice of Norwich, All Saints, with Norwich, Saint Julian, are now full, the Reverend Herbert Suffield Maude-Roxly being the present Incumbent of the said Benefice of Norwich, Saint John, Timberhill, and the Reverend Paul Jevon Raybould being the present Incumbent of the said United Benefice of Norwich, All Saints, with Norwich, Saint Julian, and the said Benefice of Norwich, Saint Peter, Parmentergate, is at present vacant."

"And whereas the Advowson or perpetual right of Patronage of and presentation to each of the said Benefices of Norwich, Saint John, Timberhill, and Norwich, Saint Peter, Parmentergate, now belongs to one and the same body of Patrons:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Bertram, Bishop of Norwich (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

"1. That the said Benefice of Norwich, Saint John, Timberhill, and the part of the said United Benefice of Norwich, All Saints, with Norwich, Saint Julian, which consists of the said Benefice of Norwich, All Saints, shall be permanently united together and form one Benefice with Cure of Souls under the style of 'The United Benefice of Norwich, Saint John, Timberhill, with Norwich, All Saints,' but the Parishes of the said Benefices shall continue distinct in all respects.

"2. That the said Benefice of Norwich, Saint Peter, Parmentergate, and the part of the said United Benefice of Norwich, All Saints, with Norwich, Saint Julian, which consists of the said Benefice of Norwich, Saint Julian, shall be permanently united together and form one Benefice with Cure of Souls under the style of 'The United Benefice of Norwich, Saint Peter, Parmentergate, with Norwich, Saint Julian,' but the Parishes of the said Benefices shall continue distinct in all respects.

"3. That with the consents of the said Herbert Suffield Maude-Roxly and Paul Jevon Raybould (testified by their respectively signing this Scheme), upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette the unions shall forthwith take effect and the said Herbert Suffield Maude-Roxly if he is then Incumbent of the said Benefice of Norwich, Saint John, Timberhill, shall be the first Incumbent of the United Benefice of \mathbf{Saint} John, Timberhill, Norwich, All Saints, and the said Paul Jevon Raybould if he is then Incumbent of the said United Benefice of Norwich, All Saints, with Norwich, Saint Julian, shall be the first Incumbent of the United Benefice of Norwich, Saint Peter, Parmentergate, with Norwich, Saint Julian.
