

THE FAIRS ACT, 1873.

MONMOUTH FAIR.

Whereas on the 23rd May, 1929, a representation was made to the Secretary of State for the Home Department by the Corporation of the Borough of Monmouth that a Fair has been annually held in Monmouth on the 22nd November and that it would be for the convenience and advantage of the public that the said Fair should in future be held on the Monday in the month of November on which the second November Stock Market is held in Monmouth:

And whereas notice of the said representation and of the time when the same would be taken into consideration has been duly published in pursuance of the Fairs Act, 1873:

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fair should in future be held on the Monday in the month of November on which the second November Stock Market is held in Monmouth:

Now therefore I, as Secretary of State for the Home Department, in exercise of the powers vested in me by the Fairs Act, 1873, do hereby order that the aforesaid Fair annually held in Monmouth shall in future be held in each year on the Monday in the month of November on which the second November Stock Market is held in Monmouth.
