MERCHANT SHIPPING ACTS, 1894 TO 1906.

Notice is hereby given, in accordance with the provisions of the Rules Publication Act, 1893, that after the expiration of forty days from the date hereof, it is proposed to submit to His Majesty in Council the draft of an Order in Council under Section 80 of the Merchant Shipping Act, 1906, to provide for the registration as British Ships of vessels belonging to His Majesty which are under the control of the Government of India or a local Government in India.

And notice is hereby further given, that copies of the proposed draft Order in Council can be obtained by any public body within forty days of the date of this notice at the Privy Council Office, Whitehall.
