

**ELECTRICITY (SUPPLY) ACT, 1926.**

Notice is hereby given that the Electricity Commissioners have prepared and propose to make

(i) A Special Order fixing a scale of depreciation in relation to the acquisition of selected generating stations and main transmission lines, for the purposes of Sections 5 and 8 and the First Schedule to the Electricity (Supply) Act, 1926;

(ii) A Special Order fixing a scale of depreciation in relation to the cost of production at selected generating stations whereof the owners are a company, for the purposes of Section 7 of and the Second Schedule to the Electricity (Supply) Act, 1926; and

(iii) A Special Order fixing a scale of depreciation in relation to transmission lines used by authorised undertakers being a company for giving bulk supplies of electricity, for the purposes of Section 12 of and the Third Schedule to the Electricity (Supply) Act, 1926.

Notice is further given that any representations which any interested party may desire to make in respect of any of the aforesaid draft Special Orders should be sent by registered post addressed to the Secretary, Electricity Commission, Savoy Court, Strand, London, W.C. 2, on or before 30th September, 1929.

Copies of the aforesaid draft Special Orders in the form in which (subject to consideration of any representations which may be made) the Electricity Commissioners propose to make them can be obtained by any interested party on application to the Electricity Commission.

**ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.**

(DATED 30TH JULY, 1929.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

*Authorisation of Landing of Animals for Exceptional Purposes.*

1. The landing of the animals described in the First Schedule hereto, which are intended for exceptional purposes, is hereby allowed subject to the provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

*Definition of Quarantine Station.*

2. The premises described in the Second Schedule hereto are hereby defined as a

Foreign Animals Quarantine Station for the purpose of the detention of the animals described in the First Schedule hereto.

*Examination before Landing.*

3. No such animals as aforesaid shall be landed except with a licence granted by an Inspector of the Ministry, which licence shall not be granted unless and until the animals have been examined by a Veterinary Inspector of the Ministry and certified by him to be free from symptoms of contagious disease.

*Regulations applicable to the Animals on Landing.*

4.—(1) The animals on being landed, shall forthwith be moved under the supervision of an Inspector of the Ministry of Agriculture and Fisheries from the quay to the premises described in the Second Schedule hereto, and shall be there detained for a period of twenty-eight days. During the said period the animals shall be kept separate from all other animals and no other animals shall be moved into such premises.

(2) The animals shall not be removed from the premises described in the Second Schedule hereto otherwise than under the authority of the licence from an Inspector of the Ministry required under Article 3 (1) (*Fifth*) of the Foreign Animals (Quarantine) Order of 1896.

(3) A copy of every licence authorising the movement of any animal described in the First Schedule hereto shall be forwarded to the Ministry by the Inspector who grants the licence.
