WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 13th day of June, 1929, in the words and figures following, that is to say:—

“We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Churches and Cure (hereinafter called ‘the said United Benefice’) of Welsh Newton with Llanrothal, in the County of Hereford and in the Diocese of Hereford:—

“Whereas the Advowson or perpetual right of Patronage of and presentation to the said United Benefice of Welsh Newton with Llanrothal is vested for an estate in fee simple without incumbrances as to two third parts or shares in Arthur Clement Tweedy of the Priory House, in the Borough and County of Monmouth, Solicitor, and as to the remaining one third part or share in John Brawn, of Cawdor Cottage, Ross, in the said County of Hereford, Auctioneer:

“And whereas the said Arthur Clement Tweedy and John Brawn are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said United Benefice of Welsh Newton with Llanrothal, should be transferred to and be vested in the Bishop of Hereford for the time being:

“And whereas the Right Reverend Martin Linton, now Bishop of Hereford, is willing to accept such transfer, and in token of such his

willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Martin Linton, Bishop of Hereford, has executed this Scheme as hereinafter mentioned:

“And whereas the transfer of the Patronage of the said United Benefice of Welsh Newton with Llanrothal which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parishes or Districts in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parishes of Welsh Newton and Llanrothal:

“Now, therefore, with the consents of the said Arthur Clement Tweedy and John Brawn (in testimony whereof they have signed and sealed this Scheme), and with the consent of the said Martin Linton, Bishop of Hereford (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said United Benefice of Welsh Newton with Llanrothal shall be transferred to the said Martin Linton, Bishop of Hereford, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Martin Linton, Bishop of Hereford, and by his successors in the same Bishopric for ever.

“And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.”
