said roadway for a distance of 31 chains or thereabouts to the boundary of the Parliamentary Borough of Bournemouth, and extending thence south eastward along such Parliamentary Borough Boundary for a distance of 60 chains or thereabouts to the point where it crosses the middle of the footpath leading from Throop to Castle Lane near Strouden Farm and extending thence south westward along the middle of the said footpath for a distance of 3 chains or thereabouts to the point where it reaches the northern side of Castle Lane, and extending thence first southward to and then westward along the middle of Castle Lane for a distance in all of 1 chain or thereabouts to its junction with the roadway leading past the western side of Strouden Farm, and extending thence south westward along the middle of such roadway for a distance of 4 chains or thereabouts to its junction with the private roadway leading through Strouden Farm, and extending thence first south east-ward and then southward along the middle of such private roadway for a distance of 11 chains or thereabouts to its junction with the road called Broad Avenue, and extending thence first south eastward, then southward, and then again south eastward along the middle of Broad Avenue for a distance of 30 chains or thereabouts to its junction with the road called Queen's Park Avenue, and extending thence westward along the middle of Queen's Park Avenue (thereby following in part the boundary which divides the said New Parish of Saint John the Evangelist, Holdenhurst, from the New Parish of Saint Andrew, Bournemouth, in the said County and Diocese) for a distance of 60 chains or thereabouts to its junction with Charminster Road and Green Road, and extending thence westward along the middle of Green Road (thereby crossing the boundary which divides the said New Parish of Saint John the Evangelist, Holdenhurst, from the said New Parish of Saint Alban, Bournemouth, and following in part the boundary which divides the said New Parish of Saint Alban, Bournemouth, from the said New Parish of Saint John, Moordown) for a distance of 30 chains or thereabouts to its junction with Ripon Road, at which point the said imaginary line commenced."

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly herein-before mentioned Act, been transmitted to the Patron and to the Incumbents of the Cures out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patron and Incumbents have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Winchester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 13th day of June, 1929, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923. have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of the Benefice (being a Rectory) of Martin Hussingtree and the Benefice (being a Rectory) of Hindlip both of which Benefices are situate in the County of Worcester and in the Diocese of Worcester:

"Whereas Commissioners appointed at our request by the Right Reverend Ernest, Bishop of Worcester, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union of the said two Benefices of Martin Hussingtree and Hindlip duly made their Report to the said Bishop of Worcester and therein recommended the union of the said two Benefices and the terms for effecting the union, including an alteration of boundaries affecting the United Benefice of Tibberton with Bredicot and Warndon in the said County and Diocese, and the said Bishop of Worcester signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices based upon the terms recommended in the said Report:

"And whereas the said Benefice of Martin Hussingtree is now full the Reverend Herbert Francis George Balcomb being the present Incumbent thereof and the said Benefice of Hindlip is at present vacant:

"And whereas the said Herbert Francis George Balcomb has consented to become the first Incumbent of the United Benefice if and when the union which is hereinafter recommended and proposed shall take effect:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Ernest, Bishop of Worcester (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:--

"1. That the said Benefice of Martin Hussingtree and the said Benefice of Hindlip shall be permanently united together and form one Benefice with Cure of Souls under the style of 'The United Benefice of Hindlip with Martin Hussingtree' but the Parishes of the said Benefices shall continue distinct in all respects.

"2. That upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette the union shall forthwith take effect and the said Herbert Francis George Balcomb if he is then Incumbent of the said Benefice of Martin Hussingtree shall be the first Incumbent of the United Benefice.
