Notice by the Board of Trade of Application by the Croydon Corporation for an Amending Order under Sub-section (3) of Section 1 of the Gas Regulation Act, 1920, in respect of the Croydon Gas Company.

The Board of Trade hereby give notice that the Croydon Corporation having made application under Sub-section (3) of Section 1 of the above named Act for an Amending Order revising the powers of charging authorised by the Croydon Gas (Charges) Order, 1921, the Board propose to authorise a new standard price of 14·8d. per therm in lieu of the existing standard price of 17·8d. per therm.
