Whitehall, 14 August, 1929.

The KING has been pleased to give and grant unto Arthur Cunliffe Bernard Critchley, of White Lodge, in the parish of Dunchurch and County of Warwick, Esquire, Companion of the Distinguished Service Order, Captain Reserve of Officers, late the Argyll and Sutherland Highlanders, and to Eleanor Gladys, his wife, only child of Samuel James Waring, Baron Waring, His Royal Licence and Authority that they and their issue may take and henceforth use the surname of Waring in addition to and after that of Critchley and that they may bear the arms of Waring quarterly in the first and fourth quarters with those of Critchley, the said arms being first duly exemplified according to the Laws of Arms and recorded in the College of Arms, otherwise the said Royal Licence and permission to be void and of none effect.

And to command that the said Royal concession and declaration be recorded in His Majesty's said College of Arms.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts, of women of 18 and young persons of 16 years of age and over in boiling, wrapping and separating in

the Caramel Department at the National Works of Messrs. Fillerys Toffees Limited, Greet, Birmingham, on condition that subject to any arrangement specially made for the convenience of individual workers no worker shall be employed in the afternoon shift in consecutive weeks and that suitable cloakroom and messroom accommodation and washing facilities shall be provided.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts, of women of 18 years of age and over in winding and knitting silk fabric at the Temple Road Works of Messrs. Klynton Hosiery Company Limited, Forrest Road, Leicester, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that switable accommodation for clothing put off during working hours, facilities for preparing cooking and taking meals and washing facilities shall be provided.
