**GUILDFORD.**

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Guildford (hereinafter called the Corporation), being the Urban Sanitary Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend Section 66 of the Guildford Corporation Act, 1926, so as :—

(1) To empower the Corporation to sell, lease, or otherwise dispose of a portion of Stoke Park containing an area of 54 acres or thereabouts and situate on the north-east side of the Park, and to construct roads and sewers on such portion of the Park, and with the consent of the Minister of Health to borrow any moneys necessary for these purposes;

(2) To enable the Corporation, with the consent of the Minister of Health, to exercise the like powers in regard to any other part of Stoke Park;

(3) For the purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the Borough as may be necessary or desirable :

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is hereby given that a plan showing the portion of Stoke Park referred to in paragraph (1) above has been deposited at the Town Hall, Guildford, and may be inspected on any week-day prior to the twelfth day of November, 1929, during ordinary office hours;

And notice is hereby further given that A. E. H. Goddard, Esq., I.S.O., one of the Inspectors of the Ministry of Health, will attend at the Town Hall, Guildford, on Tuesday, the twelfth day of November, 1929, at eleven o'clock in the forenoon, to hold a Local
