## ACCRINGTON.

Whereas the Mayor, Aldermen and Burgesses of the Borough of Accrington (hereinafter called the Corporation), being the Urban Sanitary Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Accrington Corporation Act, 1905, so as:—

(1) to enable the Corporation:

(a) where a sewer and water supply sufficient for the purpose are reasonably available, to require any existing waste water closet provided at or in connection with any building to be altered so as to be converted into a fresh water closet;

(b) to contribute towards the expenses incurred in converting any such waste water closet into a fresh water closet;

(c) where the Corporation have incurred expenses on behalf of owners of property in converting any existing closet accommodation into fresh water closets, to allow such owners to repay such expenses, with interest, by instalments over a period of years;

(d) to borrow, with the consent of the Minister of Health, such sums as may from time to time be necessary for the purpose of defraying the expenses of the Corporation in connection with the conversion of existing closet accommodation;

(2) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act,
