*In two portions.*

Five Hackney Carriages:

*First Portion.*—Two carriages to stand on the West side of Wimpole Street, commencing at a point in line with the party wall of the premises of the Midland Bank Limited and Messrs. Debenham & Company and extending Southward, by kerb, as far as necessary for two carriages.

Front of vehicles toward the North.

*Second Portion.*—Three carriages to stand on the West side of Chapel Place, commencing at a point fifteen feet South of the Northern wall of St. Peter's Chapel and extending Southward, by kerb, as far as necessary for three carriages.

Front of vehicles toward the North.

The first portion of the Standing to be fed exclusively by carriages from the second portion.

AT CHAPEL PLACE,

Three Hackney Carriages:

On the West side of roadway, commencing at a point fifteen feet South of the Northern wall of St. Peter's Chapel, and extending Southward, by kerb, as far as necessary for three carriages.

Front of vehicles toward the North.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.
