parish of Hurst in the Rural District of East Ashford; the parishes of Buckland, Boughtonunder-Blean, Hernhill, Goodnestone, Graveney, Luddenham and Stone next Faversham, and parts of the parishes of Dunkirk, Faversham Without, Ospringe, and South Preston Without, in the Rural District of Faversham; the parish of Stockbury in the Rural District of Hollingbourne; the parishes of Brenzett, Brookland, Eastbridge, Fairfield, Ivychurch, Midley, Newchurch, Old Romney, St. Martins, Snargate and Snave in the Rural District of Romney Marsh; and the parishes of Appledore, Kenardington, Stone-cum-Ebony, Wittersham and Woodchurch in the Rural District of Tenterden all in the County of Kent (including the detached portions of such parishes).

Exclusion of the parish of Upper Hardres in the Rural District of Bridge in the County of Kent and the said Parish of Boughtonunder-Blean and the said part of the said parish of Dunkirk from the area of supply for water of the Canterbury Gas and Water Company.

Exclusion of the parish of Frittenden in the Rural District of Cranbrook in the county of Kent and the said parishes of Stone-cum-Ebony and Woodchurch from the area of supply for water of the Cranbrook District Water Company.

Power to Faversham Rural District Council to sell and to Company to purchase a certain reservoir of the Council in the said parish of Dunkirk and certain mains pipes and works of the Council situate in the said parishes of Boughton-under-Blean and Dunkirk in their District and maintenance and user of same by Company; Confirmation of any Agreement for those purposes, and incidental provisions.

Construction by Company of new Waterworks in the County of Kent comprising the following :---

Work No. 1.—A Reservoir in the parish of Harrietsham in the Rural District of Hollingbourne.

Work No. 2.—A Reservoir in the parish of Dunkirk in the Rural District of Faversham.

Work No. 3.—A Conduit in the said parish of Dunkirk connecting an existing line of pipes belonging to the Faversham Rural District Council with the intended Reservoir (Work No. 2).

Work No. 4.—A Covered Service Reservoir in the parish of Lenham in the Rural District of Hollingbourne.

Work No. 5.—An Elevated Service Reservoir in the said parish of Lenham.

Work No. 6.—A Conduit in the said parish of Lenham connecting an existing conduit or line or lines of pipes of the Company (which connects their existing Charing Pumping Station with their existing Warren Street Reservoir) with the intended Elevated Service Reservoir (Work No. 5).

Work No. 7.—A Reservoir in the parish of Charing in the Rural District of West Ashford.

Work No. 8.—A Reservoir in the parish of Otterden in the Rural District of Hollingbourne.

Work No. 9.—A Conduit in the said parish of Otterden and in the parishes of Doddington (detached), Newnham, Eastling, Ospringe and Norton in the Rural District of Faversham connecting the intended Reservoir (Work No. 8) with the intended Newnham Pumping Station (Work No. 10) hereinafter described.

Work No. 10.—A Pumping Station together with wells &c. (to be called "the Newnham Pumping Station") in the said parishes of Norton and Ospringe.

Work No. 11.—An adit in the said parishes of Norton and Ospringe.

Work No. 12.—A Conduit in the parish of Thornham (or Thurnham) in the Rural District of Hollingbourne connecting an existing main of the Company with the intended Thurnham Pumping Station (Work No. 13) hereinafter described.

Work No. 13.—A Pumping Station with wells &c. (to be called "the Thurnham Pumping Station") in the said parish of Thornham (or Thurnham).

Work No. 14.—A Conduit in the parishes of Thornham (or Thurnham) and Hollingbourne in the Rural District of Hollingbourne connecting the intended Thurnham Pumping Station (Work No. 13) with the intended Reservoir (Work No. 15) hereinafter described.

Work No. 15.—A Covered Service Reservoir in the said parish of Hollingbourne.

Work No. 16.—A Conduit in the Urban District of Wrotham and the parishes of Stansted and Trottiscliffe in the Rural District of Malling connecting the existing Exedown Reservoir of the Company in the said Urban District with the existing Trosley Pumping Station of the Company in the said parish of Trottiscliffe.

Work No. 17.—A Conduit in the parishes of Trottiscliffe, Addington, Leybourne (detached) and Mereworth in the Rural District of Malling and the Urban District of Wrotham connecting the said existing Trosley Pumping Station with the existing Mereworth Beech Reservoir of the Company.

Subsidiary works; limits of deviation; pumping and appropriation of underground water by means of new Works; Compulsory acquisition of and other powers as to lands, buildings, easements &c. including compulsory acquisition of easements only; Modifications of Lands Clauses Acts; Exercise of powers of Section 12 of Waterworks Clauses Act, 1847.

Stopping up alteration and diversion of so much of public footpath leading from Howe Court to Barty Farm as is situate on the lands forming part of the Enclosures in the said Parish of Thornham (or Thurnham) respectively numbered 93 and 94 on the  $\frac{1}{2500}$  Ordnance Map (Second Edition 1897) Sheet No. XLIII. 5 of the said parish in or upon which the intended Thurnham Pumping Station (Work No. 13) is to be constructed; Vesting in Company of portion of footpath stopped up and diversion and maintenance of such altered and diverted portion thereof.

Purchase by agreement leasing holding &c. of lands buildings, waters &c. for purposes of undertaking and sale lease or disposal of same
