

TRADE BOARDS ACTS, 1909 AND 1918.

RETAIL BESPOKE TAILORING TRADE BOARD (ENGLAND AND WALES).

PROPOSAL TO FIX AND TO VARY MINIMUM RATES OF WAGES IN CERTAIN AREAS FOR CERTAIN CLASSES OF FEMALE WORKERS IN SUCH AREAS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April, 1927, the Retail Bespoke Tailoring Trade Board (England and Wales) HEREBY GIVE NOTICE that they PROPOSE TO FIX AND TO VARY Minimum Rates of Wages for certain Classes of Female Workers in the Area comprising the Counties of Lancashire (Eastern Part) and Westmorland, and the Urban Districts of Barnoldswick, Earby and Skipton in the County of Yorkshire and in the Area comprising the Counties of Cheshire, Lancashire (Western Part) and Shropshire.

Information in respect of the Trade Board's Proposals may be obtained on application to the Secretary of the Trade Board at the address given below.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board WILL CONSIDER ANY OBJECTIONS to the above Proposals which may be lodged with them within two months from the 10th day of January, 1930. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary, Retail Bespoke Tailoring Trade Board (England and Wales), 1, Whitehall Gardens, London, S.W. 1. It is desirable that Objections should state precisely, and, so far as possible, with reasons what is objected to.
