"(4) A portion of the Parish of Highcliffe (the boundaries of which portion are delineated on the map attached to the annexed Scheme and thereon verged violet) may be advantageously separated from the Parish of Highcliffe and annexed to the Parish of Christchurch to which it is contiguous.

"(5) A portion of the Parish of Milton (the boundaries of which portion are delineated on the map attached to the annexed Scheme and thereon hatched green) may be advantageously separated from the Parish of Milton and annexed to the Parish of Highcliffe to which it is contiguous.

"(6) A portion of the Parish of Hinton Admiral (the boundaries of which portion are delineated on the map attached to the annexed Scheme and thereon verged orange) may be advantageously separated from the Parish of Hinton Admiral and annexed to the Parish of Highcliffe to which it is contiguous.

"(7) A portion of the Parish of Sopley (the boundaries of which portion are delineated on the map attached to the annexed Scheme and thereon hatched red) may be advantageously separated from the Parish of Sopley and annexed to the Parish of Bransgore to which it is contiguous.

"(8) A portion of the Extra Parochial place known as the New Forest (the boundaries of which portion are delineated on the map attached to the annexed Scheme and thereon verged yellow) may be advantageously annexed to the Parish of Hinton Admiral to which it is contiguous.

"Major Sir George Meyrick, Baronet, is the Patron of the said Benefice of Hinton Admiral and the Reverend Charles Osborne Smeathman Hatton is the present Incumbent thereof.

"The Reverend Henry Meredith Larner is the Patron of the said Benefice of Milton and the Reverend William Gregor Maxwell Hutchison is the present Incumbent thereof.

"Amy Gertrude Jesson, Arthur William Mosley Jesson and Harold Percy Jesson are the Patrons of the said Benefice of Bransgore and the Reverend Edgar Albert Luff is the present Incumbent thereof.

"General The Honourable Edward James Montagu Stuart-Wortley, C.B., C.M.G., M.V.O., D.S.O., is the Patron of the said Benefice of Highcliffe and the Reverend Charles Hamerton Gould is the present Incumbent thereof.

"I, Frank Theodore, Bishop of Winchester, am the Patron of the Benefice of Christchurch by virtue of my Bishopric and the Reverend Canon William Hayne Gay is the present Incumbent thereof.

"The Dean and Chapter of Canterbury are the Patrons of the Benefice of Sopley and the Reverend David Fitz Herbert Wright is the present Incumbent thereof.

"That pursuant to the directions contained in the twenty-sixth section of the Pluralities Act, 1933, I, the said Bishop, have drawn up a Scheme in writing annexed to this Representation describing the mode in which it appears to me that the alterations above proposed may best be effected and how the changes

consequent on such alterations in respect of ecclesiastical jurisdiction, glebe lands Tithes rent charges and other ecclesiastical dues rates and payments and in respect to Patronage and rights to pews may be made with justice to all parties interested, and I do hereby submit the same to Your Grace together with the Consents in writing of the Patrons of the said Benefices of Hinton Admiral, Milton, Bransgore, Highcliffe, Christchurch and Sopley and also the Consents of the Incumbents of the said Benefices to the intent that if Your Grace shall on full consideration and enquiry be satisfied with such Scheme you may certify the same and such Consents aforesaid to His Majesty in Council."

And whereas the said Scheme drawn up by the said Bishop and the Consents referred to in the said Representation are as follows:—

"SCHEME.

"It is proposed to separate from the Parish of Milton and annex to the Parish of Hinton Admiral all those two portions of the Parish of Milton which are delineated on the map hereto annexed and thereon verged red.

"It is also proposed to separate from the Parish of Bransgore and annex to the Parish of Hinton Admiral all that portion of the Parish of Bransgore which is delineated on the said map hereto annexed and thereon verged green.

"It is also proposed to separate from the Parish of Highcliffe and annex to the Parish of Hinton Admiral all those two portions of the Parish of Highcliffe which are delineated on the said map hereto annexed and thereon verged blue.

"It is also proposed to separate from the Parish of Highcliffe and annex to the Parish of Christchurch all that portion of the Parish of Highcliffe which is delineated on the said map hereto annexed and thereon verged violet.

"It is also proposed to separate from the Parish of Milton and annex to the Parish of Highcliffe all that portion of the Parish of Milton which is delineated on the said map hereto annexed and thereon hatched green.

"It is also proposed to separate from the Parish of Hinton Admiral and annex to the Parish of Highcliffe all that portion of the Parish of Hinton Admiral which is delineated on the said map hereto annexed and thereon verged orange.

"It is also proposed to separate from the Parish of Sopley and annex to the Parish of Bransgore all that portion of the Parish of Sopley which is delineated on the said map hereto annexed and thereon hatched red.

"It is also proposed to annex to the Parish of Hinton Admiral all that portion of the Extra Parochial place known as the New Forest which is delineated on the said map hereto annexed and thereon verged yellow.

"That the Incumbents of Hinton Admiral, Christchurch, Highcliffe and Bransgore shall have sole and exclusive cure of souls within those portions of the Parishes so to be separated from the Parishes of Hinton Admiral, Milton, Bransgore, Highcliffe and Sopley respectively and annexed to their respective Parishes.

"That the inhabitants of such portions so to be separated shall be entitled to accommoda-
