residual products arising from, resulting in, or producible from such manufacture, and to make, use, store, utilise and distribute all such residual products and materials as aforesaid. The lands hereinbefore referred to are as follows:---

EXISTING GAS LANDS.

First—All those two pieces or parcels of land situate on either side of Lawrence Street in the borough belonging or reputed to belong to the Corporation being the site of the existing gasworks of the Corporation comprising an area of 1.498 acres or thereabouts and bounded on or towards the east by Havelock Road on or towards the north by Stanley Street on or towards the west by Winder Street and on or towards the south by a tramway line and other property belonging or reputed to belong to the Trustees of the late Alan De Lancy Curwen.

Secondly.—All that piece or parcel of land situate at Clay Flatts in the borough belonging or reputed to belong to the Corporation being the site on which the existing gasholders are situate and containing 1.489 acres or thereabouts and bounded on or towards the east by Gas Street on or towards the north by land belonging or reputed to belong to the Trustees of the late Alan De Lancy Curwen on or towards the west by land belonging or reputed to belong to Ralph Falcon Cooke and on or towards the south by land belonging to the Corporation of Workington.

3. To authorise the Corporation to purchase by agreement additional lands for the purposes of their gas undertaking and to enable the Corporation to sell, lease, exchange, dispose of, or to retain, hold and use lands, and to make provision for the proceeds arising from the sale of surplus lands.

4. To make provision as to the price or prices to be charged for gas in the existing and added limits or in any part or parts thereof with power to the Corporation (if thought fit) to charge different prices in different parts of the limits of supply as extended by the Order; and to make provision as to the charges for the supply of gas by means of prepayment meters.

5. To confer upon the Corporation general powers for the better regulation of their gas undertaking including powers with respect to the laying of pipes in private streets, and for ancillary purposes; dwelling houses for employees, offices showrooms &c.; to provide, sell, let for hire, fix, repair and remove gas meters, lamps, stoves, engines, and other apparatus and fittings, and to exclude the same from distress; provisions as to the application of the proceeds arising from sale, or hire of fittings; exemption from obligation to supply gas in certain cir-cumstances to be specified in the Order; the supply of gas to premises having a supply of electricity, gas, or other form of energy from other sources and the charges to be made therefor; refusal of supply to persons in debt for other premises; the removal of fittings where gas supply discontinued; consumers to give notice to Corporation before removal; notice to discontinue supply of gas; mode of cutting off supplies; recovery of expenses of reconnecting discontinued supplies; charges for special readings of meters; inspection and testing of meters and to specify by whom charges for the testing of meters in certain cases shall be borne; use of anti-fluctuator with gas engines; periods of error in defective meters; as to construction and placing of pipes &c.; provision of valve where high-pressure air is used; power to compel repairs in case of danger; the supply to or by and purchase by and from the Corporation of gas in bulk and the taking of licences for use of patents.

6. To authorise the Corporation to borrow money for the purposes of the Order or their gas undertaking including working capital and for paying the costs, charges and expenses of the Order, and to authorise the formation, maintenance and application of reserve fund; to provide for the keeping of separate accounts in respect of gas undertaking of Corporation; application of revenue, and to enact such financial and other provisions as may be necessary or expedient for enabling the Corporation to carry on and develop their gas undertaking, and for the purpose of giving effect to the provisions of the Order.

7. To enable the Corporation to exercise all such powers as may be necessary or convenient for the purposes of the Order, and to confer upon them all such other powers as are now usually conferred upon local authorities in connection with the supply of gas.

8. To vary or extinguish all rights and privileges which would or might interfere with the objects of the Order, and to confer other rights, powers and privileges.

9. To incorporate and apply with or without modification all or some of the provisions of the Lands Clauses Acts and the Gasworks Clauses Acts 1847 and 1871, the Gas Undertakings Acts 1920 and 1929, and to alter, amend or repeal all or any of the provisions of the Act 3 Vict. Ch. XLV (dated 19th May 1840) relating to the town of Workington, the Workington Order 1914 confirmed by the Local Government Boards Provisional Orders Confirmation (No. 6) Act 1914, and any other Act or Order of or affecting the Corporation or their gas undertaking.

Any local or other public authority, company or person desirous of bringing before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W. 1, and despatched on or before the 3rd day of March, 1930.

Any such objection must state (a) the specific grounds of objection and (b) the omissions, additions and modifications asked for.

A copy of the objection must be forwarded to the undersigned Town Clerk and Parliamentary Agent at the same time as it is sent to the Board of Trade.

An Ordnance Map on a scale of not less than one inch to a mile showing the situation of the existing gas works of the Corporation and the boundaries of the existing and proposed extended limits of supply, and printed copies of the draft Order have been deposited for public inspection with the Clerk of the Peace for the County of Cumberland at his office at Carlisle and at the office of the Town Clerk at Workington, and prints of the draft Order may be obtained at the price of one shilling each
