(1) An order entitled the Berks, Bucks and Oxon Joint Vagrancy Committee Order, 1930, for combining the Counties of Berks, Buckingham and Oxford, and the County Boroughs of Oxford and Reading, for the purpose of the better administration of the relief of casual poor persons within the combined areas;

(2) an order entitled the South Midland Joint Vagrancy Committee Order, 1930, for combining the Counties of Warwick and Worcester, and the County Boroughs of Birmingham, Coventry, Smethwick and Worcester, for the purpose of the better administration of the relief of casual poor persons within the combined areas;

(3) an order entitled the Suffolk Joint Vagrancy Committee Order, 1930, for combining the administrative Counties of East Suffolk and West Suffolk, and the County Borough of Ipswich, for the purpose of the better administration of the relief of casual poor persons within the combined areas;

(4) an order entitled the North Wales Joint Vagrancy Committee Order, 1930, for combining the Counties of Anglesey, Caernarvon, Denbigh, Flint, Merioneth and Montgomery, for the purpose of the better administration of the relief of casual poor persons within the combined areas; and

(5) an order entitled the South Wales Joint Vagrancy Committee Order, 1930, for combining the Counties of Brecon, Glamorgan, Monmouth and Radnor, and the County Boroughs of Cardiff, Merthyr Tydfil, Newport and Swansea, for the purpose of the better administration of the relief of casual poor persons within the combined areas.

#### RURAL DISTRICT OF EVESHAM.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

**B**Y an Order dated the twenty-seventh day of January, 1930, the Minister of Health has Declared that, on and after the seventeenth day of February, 1930, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the contributory places of Offenham and South Littleton within the Rural District of Evesham, namely:—

Section 30 (which relates to the repair or enclosure of dangerous places) comprised in Part II of the said Act.

The above provisions are declared to be in force subject, as regards Section 30 aforesaid, to the conditions specified in the Order.
