## HOLLOW-WARE TRADE BOARD (GREAT BRITAIN).

## PROPOSAL TO FIX PIECE-WORK BASIS TIME-RATES FOR MALE WORKERS AND TO VARY OVERTIME RATES FOR MALE PIECE-WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 21st April, 1927, the Hollow-ware Trade Board (Great Britain) HEREBY GIVE NOTICE that they PROPOSE to FIX Piece-Work Basis Time-Rates for male workers and to VARY Overtime Rates for male Piece-Workers.

Particulars of the proposed rates and variation may be obtained on application to the Secretary of the Trade Board.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any Objection to the above Proposal to Fix and Vary, which may be lodged with them within two months from the 4th March, 1930. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary, Hollow-ware Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1. It is desirable that Objections should state precisely, and so far as possible, with reasons what is objected to.

## COAL MINES ACT, 1911.

The Secretary for Mines gives notice that on the 11th day of February, 1930, he made General Regulations under Sections 85 and 86 of the Coal Mines Act, 1911, to apply to all mines under that Act, and relating to the rendering of first-aid treatment to any person in or about a mine who may be injured or be taken ill.

The Regulations, which may be cited as the Coal Mines General Regulations (First Aid), 1930, come into force on the first day of April, 1930.
