

TRADE BOARDS ACTS, 1909 AND 1918.

VARIATION OF MINIMUM RATES IN THE CEREMENT-MAKING SECTION OF THE COFFIN FURNITURE AND CEREMENT-MAKING TRADE.

The Coffin Furniture and Cerement-Making Trade Board (Great Britain) have issued a Notice, dated 25th March, 1930, settling out variations in the Minimum Rates for Female Workers in the Cerement-Making Section of the Trade, for periods *not* dependent on the Cost of Living Figure, which become effective under an Order of the Minister of Labour as from 1st April, 1930.
