## PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

**N**OTICE is hereby given that by an Order dated the fifth day of March, one thousand nine hundred and thirty, the Minister of Health has confirmed an Order made on the thirty-first day of January, one thousand nine hundred and thirty, by the Lord Mayor Aldermen and Citizens of the City of Birmingham acting by the Council in pursuance of Section 112 of the Public Health Act, 1875, as amended by Section 51 of the Public Health Acts Amendment Act, 1907, declaring the trade of a Fish Frier within the City of Birmingham to be an offensive trade.

## RURAL DISTRICT OF NEWBURY.

**B**Y an Order dated the third day of March, 1930, the Minister of Health has declared that, on and after the twenty-fourth day of March, 1930, the following provisions shall be in force in the contributory place of Cold Ash, within the Rural District of Newbury, so far as regards the street known as Cromwell Road, extending in a northerly direction for a distance of 504 feet from its junction with Kiln Road, namely:—

1. the provisions of the Private Street Works Act, 1892;
2. the provisions of Section 19 of the Public Health Acts Amendment Act, 1907 (which relate to urgent repairs to private streets).
3. The expenses (except establishment and certain other expenses) payable by the Council in the execution of the above powers are declared by the Order to be special expenses.

The above provisions are declared to be in force subject, as regards Section 19 of the Public Health Acts Amendment Act, 1907, to the condition specified in the Order.

## GAS UNDERTAKINGS ACT 1929.

## THE CRANLEIGH GAS AND ELECTRICITY COMPANY LIMITED.
