MERCHANDISE MARKS ACT, 1926.

REFERENCE TO STANDING COMMITTEE.

In accordance with the provisions of Section 2, sub-Section (4) of the Merchandise Marks Act, 1926, the Board of Trade give notice that in pursuance of an application received by them for the making of an Order in Council to require imported goods of certain classes and descriptions to bear an indication of origin they have made a reference to the Standing Committee appointed by them under the Act in respect of the following imported fertilisers and feeding stuffs:—

(a) Bone meal and bone flour, whether raw, degreased or degelatinised;

(b) hoof meal, horn meal and mixtures thereof;

(c) meat meal, meat and bone meal and carcase meal;

(d) dried blood, whether ground or unground.

Attention is called to the fact that while under the provisions of the above Act the Committee must in every case referred to them consider whether the goods should bear an

indication of origin at the time of sale or exposure for sale, they may also at their discretion consider and report on the question whether such goods should bear an indication of origin at the time of importation.
