numbered 190 and 191 such number of journeys with their omnibuses plying for hire in addition to those now made in the maintenance by them of any service or services on any approved route, as may be necessary for them to maintain the services respectively shown in Column 2 of the said Schedule; provided that

nothing herein contained shall be deemed to affect or derogate from the powers of the Commissioner of Police of the Metropolis under the provisions of Section 52 of the Metropolitan Police Act, 1839, to give directions to constables for keeping order and for preventing any obstruction of the thoroughfares.

LONDON AND HOME COUNTIES ELECTRICITY DISTRICT.

THE IMPORTATION OF RAW CHERRIES (AMENDMENT) ORDER OF 1930.

The Minister of Agriculture and Fisheries by virtue and in exercise of the powers vested in him under the Destructive Insects and Pests Acts, 1877 to 1927, and of every other power enabling him in this behalf hereby orders as follows:-

Amendment of the Importation of Raw Cherries Order of 1930.

1. In Article 2 (b) and (c) of the Importation of Raw Cherries Order of 1930 and in the Schedule to that Order there shall be substituted for the words "sixth day of July" wherever they appear the words "twenty-fourth day of June".
