For the purposes of the Electricity (Supply) Acts, 1882 to 1928, and all Orders and Licences made or granted and issued thereunder, and any Local Act relating to the supply of elec-tricity, the Electricity Commissioners approve of the construction and pattern of the meter (hereinafter described) for the measurement of electrical energy when supplied on the constant pressure, two wire, single phase alternating current system, and known as the "Ferranti" Type F.C.c. Provided that the meter be constructed as described in the specification and drawings de-posited at the National Physical Laboratory, Teddington, Middlesex, dated and numbered 15th September, 1928, and 8th March, 1930, and Nos. 123 and 128 respectively, and be in accordance with the pattern meters Nos. 4006156, 4006157, 4006158, 4004478, 4007187 and 4048434, deposited at the National Physical Laboratory on the 13th December, 1928, the 10th January, 1929, 15th March, 1929, and the 11th March, 1930, by or on behalf of Ferranti Limited, Hollinwood, Lancashire, and sealed by the National Physical Laboratory at the instance of the Electricity Commissioners.

The Electricity Commissioners further approve of the means provided for fixing meters of this description and for connecting them with the service lines as described in the specification and drawings above referred to.

The approval by the Electricity Commissioners dated the 16th May, 1929, of the construction and pattern of the "Ferranti" Type F.C.c. ## THE IMPORTATION OF RAW APPLES ORDER OF 1930.

The Minister of Agriculture and Fisheries has made the above Order under the Destructive Insects and Pests Acts, 1877 to 1927.

The effect of the Order is to prohibit the landing in England or Wales between the 7th July and the 15th November in each year of any raw apples grown in the United States of America unless each consignment is accompanied by a certificate in a specified form, signed by a duly authorised Inspector of the Federal Department of Agriculture.

The certificate prescribed must be delivered to the officer of Customs and Excise with the

entry relating to the consignment.

Raw apples landed without the certificates prescribed in the Order must be destroyed at the expense of the importer unless they are reexported or are disposed of in accordance with the terms of a licence issued by an Inspector of the Ministry.

An Inspector may enter any premises and open, examine and take samples of any raw
