GENERAL WASTE MATERIALS RECLAMATION TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 21st April, 1927, the General Waste Materials Reclamation Trade Board (Great Britain) HEREBY GIVE NOTICE that they PROPOSE TO VARY certain Minimum Rates of Wages for Male and Female Workers.

Particulars of the proposed variation may be obtained on application to the Secretary of the Trade Board.

In accordance with Section 3 (5) of the Trade Boards Act, 1918; the Trade Board will CONSIDER ANY OBJECTION to the above Proposal to Vary which may be lodged with them within two months from the 8th July, 1930.
