the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all those portions of the said Parish of Glenfield, together with the contiguous territory called or known as the Extra Parochial Place of Leicester Forest East, in the said County and Diocese, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are, with the said extra parochial territory, delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Bartholomew, situate at Kirby Muxloe as aforesaid, and that the same should be named 'The District Chapelry of Saint Bartholomew, Kirby Muxloe.'

"And with the like consent of the said Cyril Charles Bowman, Bishop of Leicester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint Bartholomew situate at Kirby Muxloe as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings, and burials should be paid and belong to the minister of the same church for the time being.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Bartholomew, Kirby Muxloe, comprising:--

"I. All that portion of the Parish of Glenfield, and the whole of the Extra Parochial Place known as Leicester Forest East, both in the County of Leicester and in the Diocese of Leicester, which, taken together, are comprised within and are co-extensive with the Civil Parishes of Kirby Muxloe and East Leicester Forest.

"II. And also all that other portion of the said Parish of Glenfield which is bounded upon the south by a detached portion of the Parish of Aylestone, in the said County and Diocese, upon the west by the said Extra Parochial Place known as Leicester Forest East, and upon the remaining sides, that is to say, upon the north and upon the east, by an imaginary line commencing at the point where the boundary which divides the said Extra Parochial Place known as Leicester Forest East from the said Parish of Glenfield crosses the middle of the Leicester and Burton Branch Line of the London, Midland and Scottish Railway, and extending thence eastward along the middle of the said line of railway for a distance of 34 chains or thereabouts to the centre of the bridge which carries the roadway leading from the house and premises known as Gallard's Hill to Hinckley Road across such railway, and extending thence southward along the middle of the said roadway for a distance of 7 chains or thereabouts to its junction with Hinckley Road, and extending

thence south westward in a straight line across the close numbered 44a upon the Ordnance Survey Map of the Civil Parish of Braunstone published in the year 1915 on the scale of 25 inches to a mile and also upon the map or plan annexed to this Representation for a distance of 12 chains or thereabouts to the north western end of the fence dividing the closes numbered 244 and 241 upon the said maps, and extending thence first south eastward and then in various directions along the fences which divide the said close numbered 244 and the closes numbered 246 and 238 upon the said maps from the said close numbered 241 and the closes numbered 242, 243, and 44 upon the same maps for a distance of 22 chains or thereabouts to the point where the fence which divides the said close numbered 239 from the said close numbered 44 reaches the northern side of the road leading from Kirby Muxloe to Braunstone and extending thence first south westward to and then south eastward along the middle of the last mentioned road for a distance in all of 22 chains or thereabouts to a point opposite to the northern end of the fence which divides the close numbered 206 upon the said maps from the close numbered 240 upon the same maps, and extending thence south westward first across the close numbered 239 upon the said maps and then along the fences which divide the said close numbered 206 and the closes numbered 205 and 156 upon the said maps from the said close numbered 240 and the closes numbered 47, 48, 39 and 1, upon the same maps for a distance in all of 47 chains or thereabouts to the point where the fence which divides the said close numbered 156 from the said close numbered 1 reaches the northern side of the stream flowing past the southern side of such closes, and extending thence southward in a straight line to the boundary which divides the said Parish of Glenfield from the said detached portion of the Parish of Aylestone."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Leicester.
