boundaries of the said New Parishes should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Reverend Michael, Bishop of Saint Albans (in testimony whereof he has signed and sealed this Scheme or Representation) we, the said Ecclesiastical Commissioners, humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Christ Church, Luton, of the said New Parish of Stopsley, of the said New Parish of Saint Matthew, High Town, Luton, of the said New Parish of Saint Andrew, Woodside, of the said New Parish of Saint Saviour, Luton, and of the said New Parish of Saint Paul, Luton, shall be altered so that (first) all that portion of the said New Parish of Stopsley which is described in the First Schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured blue shall be dissevered from such New Parish and shall be annexed to and shall in future form part of the said New Parish of Saint Matthew, High Town, Luton; (secondly) all that portion of the said New Parish of Saint Matthew, High Town, Luton, which is described in the Second Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured yellow shall be dissevered from such New Parish and shall be annexed to and shall in future form part of the said New Parish of Stopsley; (thirdly) all that portion of the said New Parish of Saint Matthew, High Town, Luton, which is described in the Third Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured brown shall be dissevered from such New Parish and shall be restored to and shall in future form part of the Parish of Luton, in the said County and Diocese; (fourthly) all those portions of the said Parish of Luton, which are described in the Fourth Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon coloured purple shall be dissevered from such Parish and shall be annexed to and shall in future form part of the said New Parish of Saint Paul, Luton; (fifthly) all that portion of the said Parish of Luton, which is described in the Fifth Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured pink shall be dissevered from such Parish and shall be annexed to and shall in future form part of the said New Parish of Saint Andrew, Woodside; and (sixthly) all those portions of the said Parish of Luton, and of the said New Parish of Christ Church, Luton, which are described in the Sixth Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon coloured green, shall be dissevered from such Parish and New Parish respectively and shall be annexed to and shall in future form part of the said New Parish of Saint Saviour, Luton.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the herein-before mentioned Acts or of any of them or of any other Act of Parliament.

"All which we humbly represent, recommend and propose to Your Majesty in Council.

"THE SCHEDULES to which the foregoing Scheme or Representation has reference.

"The First Schedule.

"The territory to be dissevered from the New Parish of Stopsley, in the County of Bedford and in the Diocese of Saint Albans, and to be annexed to the New Parish of Saint Matthew, High Town, Luton, in the said County and Diocese, being:—

"All that portion of the said New Parish of Stopsley which is bounded upon the west, upon the south west and upon the south east by the said New Parish of Saint Matthew, High Town, Luton, and upon the remaining side, that is to say, upon the north, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Matthew, High Town, Luton, from the said New Parish of Stopsley at the junction of Winch Street with Ridgway Road, and extending thence north westward in a straight line for a distance of 5 chains or thereabouts to the junction of Colin Road with the road called Richmond Hill, and extending thence first westward, then north westward and then northward along the middle of Richmond Hill for a distance of 16 chains or thereabouts to a point opposite to the middle of the footpath leading to People's Park and extending thence south westward to and along the middle of the said footpath for a distance in all of 52 chains or thereabouts to a point opposite to the eastern end of the wall or fence forming the northern boundary of People's Park, and extending thence first eastward to and then first eastward then northward, and then again eastward along the said wall or fence for a distance in all of 18 chains or thereabouts to the boundary which divides the said New Parish of Stopsley from the said New Parish of Saint Matthew, High Town, Luton.

"The Second Schedule.

"The territory to be dissevered from the said New Parish of Saint Matthew, High. Town, Luton, and to be annexed to the said. New Parish of Stopsley, being:—

"All that portion of the said New Parish of Saint Matthew, High Town, Luton, which is bounded upon the north east by the said New Parish of Stopsley, and upon the remaining sides, that is to say, upon the south east and upon the west, by an imaginary line commencing at the junction of Hitchin Hoad with Hightown Road where the boundaries of the said New Parish of Saint Matthew, High Town, Luton, of the said New Parish of Stopsley, and of the Parish of Luton, in the said County and Diocese, all meet, and extending thence south westward along the middle of Hightown Road for a distance of 3 chains or thereabouts to its junction with Winch Street,
