

Avenue for a distance of 13½ chains or thereabouts to its junction with the road called Muirhead Avenue East, and extending thence north eastward along the middle of Muirhead Avenue East for a distance of 36 chains or thereabouts to its junction with the road called Stalisfield Avenue, and extending thence north westward along the middle of Stalisfield Avenue for a distance of 38½ chains or thereabouts to its junction with Carr Lane, and extending thence westward along the middle of Carr Lane for a distance of 14 chains or thereabouts to its junction with the road called Utting Avenue East, and extending thence south westward along the middle of Utting Avenue East for a distance of 41 chains or thereabouts to the centre of the bridge which carries the said Manchester and Southport Line of Railway across such road, upon the boundary which divides the said Parish of West Derby from the said New Parish of Saint Andrew, Clubmoor."

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Patron and to the Incumbent of the Parish of West Derby out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patron and Incumbent have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Liverpool.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the Second Session of Parliament, held in the 5th year of Her late Majesty Queen Victoria, Chapter 26, Sections 1 and 2, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 22nd day of May, 1930, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the Second Session of Parliament, held in the fifth year of Her late Majesty Queen Victoria, Chapter 26, Sections one and two, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for relieving the Bishop of London of one of the houses of residence belonging to the See:

"Whereas there are two houses of residence belonging to the See of London, the one situate at Fulham in the County of Middlesex known as Fulham Palace and being the ancient Episcopal Residence of the See and the other in St. James's Square in the City of Westminster and known as London House:

"And whereas it has been represented to us by the Right Honourable and Right Reverend Arthur Foley, Bishop of London, that the said house of residence situate in St. James's Square and known as London House is no longer required as a residence for the Bishop:

"And whereas it appears to us to be expedient that arrangements should be made for relieving the Bishop of London of the said house of residence known as London House and for providing for the sale thereof with the appurtenances thereto belonging in the manner hereinafter recommended and proposed:

"Now, therefore, with the consent of the said Arthur Foley, Bishop of London, testified by his having signed this Scheme and affixed hereto his episcopal seal, we, the said Ecclesiastical Commissioners for England, humbly recommend and propose as follows, that is to say:—

"That the said Bishop be authorized and empowered to vest in us the said Ecclesiastical Commissioners, the whole estate, right, title, and interest of him the said Arthur Foley, Bishop of London, and of his successors, of in and to the said house of residence known as London House (St. James's Square), with the appurtenances thereto belonging upon trust that we, the said Ecclesiastical Commissioners, at such time or times and in such manner as we in our discretion shall determine shall sell and dispose of the same for such price and upon such terms as we may decide and until such sale upon trust for the Bishop of London for the time being. And that all moneys received by us on account of the sale of the said house of residence and the appurtenances thereto belonging or of any part thereof, except such sum as the purchaser shall pay for fixtures belonging to the Bishop personally shall be held and applied by us for the purposes and in the manner next hereinafter mentioned, that is to say, that in the first place there shall be discharged thereout all costs, charges and expenses of and incident to the sale and that the residue of the said moneys together with all interest or dividends received in respect of the investment thereof shall be accumulated and the accumulated sum or the investments representing the same shall be applied by us to such purposes agreed upon between us and the Bishop of London for the time being as may be sanctioned by and in conformity with the provisions of any Act of Parliament or Measure of the Church Assembly which may hereafter be passed in relation to the matter.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending or proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament, or Measure of the Church Assembly."

And whereas the said Scheme has been approved by His Majesty in Council:
