

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 19th day of June, 1930, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the Parish of West Derby and partly out of the New Parish (sometime Consolidated Chapelry) of Emmanuel, Fazakerley, both in the County of Lancaster and in the Diocese of Liverpool:

"Whereas we are satisfied that the said Parish of West Derby and the said New Parish of Emmanuel, Fazakerley, are Cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said Parish of West Derby and of the said New Parish of Emmanuel, Fazakerley, which are hereinafter mentioned and described should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas by a certain Deed bearing date on or about the 19th day of June, 1930, and made or expressed to be made under the authority of the 'New Parishes Acts, 1848, 1844 and 1856' or some or one of them between the Reverend Joseph Percy Noel Potter, Rector or Incumbent of the Rectory of the said Parish of West Derby, of the first part, the Reverend

Percy Stewart, of Polesacre, Crawley, in the County of Sussex, Clerk in Holy Orders, the Patron of the said Rectory of West Derby, of the second part, the Right Reverend Albert Augustus, Bishop of Liverpool, the Ordinary of the said Rectory of West Derby, of the third part, and us, the said Ecclesiastical Commissioners, of the fourth part, the said Joseph Percy Noel Potter did, with the consents of the said Percy Stewart, as such Patron as aforesaid, and of the said Albert Augustus, Bishop of Liverpool, as such Bishop as aforesaid, grant and confirm unto the Minister or Incumbent of the District hereinafter recommended to be constituted and to his successors and, when such District shall have become a New Parish then to the Vicar or Incumbent of such New Parish and to his successors for the time being one perpetual clear yearly rentcharge or net annual sum of £100 to be payable quarterly on the 1st day of February, the 1st day of May, the 1st day of August and the 1st day of November in every year free from and clear of all deductions taxes charges rates assessments and outgoings whatsoever (except on account of the tax on income or property if any) and to be for ever issuing and payable out of and charged upon all that the said Rectory of the Parish of West Derby, and the Tithes or Tithe Commutation Rent Charges, Glebe Lands and hereditaments and all other the endowments and emoluments for the time being to the said Rectory belonging, the first of such quarterly payments to be made on such of the said quarterly days of payment as shall happen next after the date of the licence of the first Minister of the said proposed District and to be a proportionate part of the said quarterly payment calculated from the date of the said licence to the said quarterly day of payment:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £200 per annum to the Minister of the said proposed separate District so soon as the Minister shall have been duly licensed as hereinbefore mentioned and to his successors:

"And whereas the said grant of the said yearly sum of £200 will after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal, in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chapter 111:

"And whereas the said yearly rentcharge of £100 has been granted by the said Joseph Percy Noel Potter as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of Patronage of the said proposed District and, when such District shall have become a New Parish, then of the said New Parish and the nomination of the Minister or Incumbent thereof, should be assigned in the manner which is hereinafter set forth:

"And whereas the said Joseph Percy Noel Potter has nominated to us the said Albert Augustus, Bishop of Liverpool, the said Percy Stewart, and himself, the said Joseph Percy Noel Potter, as the persons to whom he desires that the whole right of Patronage of the said
