India £3 per cent. per annum Stock being the remainder of the larger sum of such Stock now held by us the said Ecclesiastical Commissioners on behalf of the said Benefice of Marstow with Pencoyd as aforesaid, and the capital sum of £29 held by the Governors of Queen Anne's Bounty on behalf of the said Benefice of Marstow with Pencoyd.

That with the consents of the Dean and Chapter of the Cathedral Church of the Blessed Virgin Mary and Saint Ethelbert at Hereford (in testimony whereof they have caused their Common or Capitular Seal to be affixed hereto), being the Patrons of the said Benefice of Hentland, with the consent of the said Martin Linton, Bishop of Hereford (testified as aforesaid), being the Patron of the said Benefice of Bridstow, with the consent of the Right Honourable John Poynder, Lord Islington, G.C.M.G., G.B.E., D.S.O. (testified by his signing this Scheme), being Patron of the said Benefice of Peterstow, and with the consent also of the said Lawrence Neville Salts Blakelock (testified as aforesaid), as the present Incumbent of the said Benefice of Tretire with Michaelchurch, and with the consents of the Reverend David Richard Evans, now Incumbent of the said Benefice of Hentland, of the Reverend Aubrey Baskerville Mynors, now Incumbent of the said Benefice of Bridstow, and of the Reverend David Jenkin Morgan Jenkins, now Incumbent of the said Benefice of Peterstow (all testified by their respectively signing this Scheme), upon the unions taking effect:—
(a) all that portion of the said Parish of Hentland containing 'Aberhall' and 'Tretire Smithy' and comprising an area of about 60 acres lying adjacent to the said Parish of Tretire with Michaelchurch (all which portion is delineated and set forth upon the Map or Plan hereto annexed and thereon coloured pink) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Tretire with Michaelchurch; (b) all those detached portions of the said Parishes of Hentland and Bridstow containing 'Daffaluke' 'Little Daffaluke,' 'Daffaluke House,' 'The Skakes,' 'Little Parks,' 'The Perks,' 'Black Norle,' 'School' and 'Greenway' (which said portions are more particularly delineated and set forth upon the said Map or Plan and there-on coloured blue) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Marstow; (c) all that detached portion of the said Parish of Peterstow containing 'Thorn House,' 'The Thorn,' 'The Yeld,' 'Porch Farm,' 'Whitfield,' 'Little Whitfield,' and 'Waygate Cottage' together with all that detached portion of the said Parish of Hentland lying west of such detached portion of the said Portion of portion of the said Parish of Peterstow (which said portions are more particularly delineated and set forth upon the said Map or Plan and thereon coloured purple) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Marstow; (d) the said Extra Parochial Place called or known as New Court shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Marstow.

"Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to suchdraft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Hereford has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme, and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Hereford.
