And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme, and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Peterborough.

**WHEREAS** the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 3rd day of July, 1930, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of the Benefice of Horninghold, the Benefice of Blaston Saint Giles, and a part of the Benefice of Hallaton, all of which Benefices are situate in the County of Leicester and in the Diocese of Leicester:

“ Whereas Commissioners appointed at our request by the Right Reverend Cyril, Bishop of Leicester, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union of the said two Benefices of Horninghold and Blaston Saint Giles with a part of the said Benefice of Hallaton, duly made their Report to the said Bishop of Leicester and therein recommended such union and the terms for effecting the same, and the said Bishop of Leicester signified in writing his approval of the said Report:

“ And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said union based upon the terms recommended in the said Report:

“ And whereas all of the said Benefices of Horninghold, Blaston Saint Giles and Hallaton are now full, the Reverend George Edward Clifton Morris being the present Incumbent of the said Benefice of Horninghold, the Reverend Charles Wolfe Murray being the present Incumbent of the said Benefice of Blaston Saint Giles, and the Reverend Francis Gill Feetham being the present Incumbent of the said Benefice of Hallaton:

“ And whereas the Advowson or perpetual right of Patronage of and presentation to each of the said two Benefices of Horninghold and Blaston Saint Giles now belongs to one and the same Patron:

“ And whereas the share of the Patronage of the United Benefices when the unions which are hereinafter recommended and proposed shall take effect which upon a fair and just apportionment would be assignable in respect of the interest of the Patrons of the said Benefice of Hallaton would in our opinion be negligible:

“ Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Cyril, Bishop of Leicester (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

“ 1. That with the consents of the said Charles Wolfe Murray and Francis Gill Feetham (testified by their signing this Scheme), upon the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme the said Benefice of Blaston Saint Giles and a part of the said Benefice of Hallaton namely all that part of the Parish of the said Benefice of Hallaton which is comprised within the area of the Civil Parish of Blaston shall be permanently united together and form one Benefice with cure of souls and one Parish for all ecclesiastical purposes under the style of ‘The Benefice of Blaston’ (hereinafter called the United Benefice of Blaston) and all lands common to the Parishes of the said Benefices of Blaston Saint Giles and Hallaton situate within the area of the said Civil Parish of Blaston, shall upon the same day be transferred and annexed for all ecclesiastical purposes to the Parish of the United Benefice of Blaston to the intent that the Incumbent for the time being of such United Benefice shall have the exclusive cure of souls therein.

“ 2. That the Church of the Parish of Blaston Saint Giles shall be the Parish Church of the United Benefice and Parish of Blaston and that the Table of Fees for the said Parish of Blaston Saint Giles shall (until revised or altered by proper authority) be the Table of Fees for the same United Benefice and Parish.

“ 3. That the said Benefice of Horninghold and the said United Benefice of Blaston shall be permanently united together and form one Benefice with cure of souls under the style of ‘The United Benefice of Horninghold with Blaston’ but the Parishes of the said Benefices shall continue distinct in all respects.

“ 4. That the union referred to in Clause 3 of this Scheme shall take effect upon the next avoidance either of the said Benefice of Horninghold or of the said United Benefice of Blaston whichever shall last be avoided after the date of the publication in the London
