

"And whereas the said Chapelry District of Brierley Hill, and the said District Chapelry of Saint Augustine, Holly Hall, Dudley, have under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become New Parishes of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Parish of Brierley Hill, and of the said New Parish of Saint Augustine, Holly Hall, Dudley, should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consents of the Right Reverend John Augustine, Bishop of Lichfield, and of the Right Reverend Ernest, Bishop of Worcester (in testimony whereof they have signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Brierley Hill, and of the said New Parish of Saint Augustine, Holly Hall, Dudley, shall be altered so that all that portion of the said New Parish of Brierley Hill, which is described in the Schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured pink shall be dissevered from such New Parish and from the said Diocese of Lichfield and shall be annexed to and shall in future form part of the said New Parish of Saint Augustine, Holly Hall, Dudley, and of the said Diocese of Worcester, and shall be included in the Archdeaconry and Rural Deanery within which the said New Parish of Saint Augustine, Holly Hall, Dudley, is comprised.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of any of them or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The territory to be dissevered from the New Parish of Brierley Hill, in the County of Stafford and in the Diocese of Lichfield, and to be annexed to the New Parish of Saint Augustine, Holly Hall, Dudley, in the County of Worcester and in the Diocese of Worcester, being:—

"All that portion of the said New Parish of Brierley Hill which is bounded upon the east by the said New Parish of Saint Augustine, Holly Hall, Dudley, upon the north by the New Parish of Pensnett, upon the south west by the New Parish of Brockmoor, both in the said County of Stafford and in the said Diocese of Lichfield, and upon the remaining side, that is to say, upon the south, by an

imaginary line commencing upon the boundary which divides the said New Parish of Brockmoor from the said New Parish of Brierley Hill at the centre of the bridge which carries Dudley Road across the Oxford, Worcester and Wolverhampton Line of the Great Western Railway, and extending thence north eastward along the middle of the said line of railway for a distance of 23 chains or thereabouts to the boundary which divides the said New Parish of Brierley Hill from the said New Parish of Saint Augustine, Holly Hall, Dudley."

And whereas drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation and such Patrons and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrars of the said Diocese of Lichfield and of the said Diocese of Worcester respectively.
