#### SCHEDULE.

##### PROPOSED VARIATION OF OVERTIME RATES.

The Trade Board Propose to Vary the Overtime Rates for Male and Female Workers by providing that the following words be substituted for the words "the days allowed as holidays under Section 35 of the Factory and Workshop Act, 1901," contained in the Proviso to Section 1 and in Section II (3) of Part III of the above-mentioned Notice F. (11):—

"Customary Public and Statutory Holidays (so far as it is lawful under the Factory and Workshop Acts and any other legislation governing employment for the worker to work during such time)."

Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any Objections to the above Proposal to Vary which may be lodged with them within two months from the 29th day of July, 1930. Such objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary, Sugar Confectionery and Food Preserving Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1.

It is desirable that the Objections should state precisely, and, so far as possible, with reasons, what is objected to.
