# COAL MINES ACT, 1911.

## EXPLOSIVES IN COAL MINES.

The Secretary for Mines gives notice that on the 26th August, 1930, he made an Order in pursuance of Section 61 of the Coal Mines Act, 1911, amending the First Schedule to the Explosives in Coal Mines Order of the 1st September, 1913 (relating to "Permitted" explosives).

The effect of the new Order is :-

(1) to add the explosive Celmonite, manufactured by Messrs. Cooke's Explosives Ltd. to the list of explosives which have passed, the Buxton Test;

(2) to restore the explosive Ammonite No. 1P, manufactured by Messrs. The Miners' Safety Explosive Co. Ltd., previously omitted from the Permitted List owing to a misunderstanding, to the list of explosives which have passed the Rotherham Test;

(3) to amend the definitions of certain permitted explosives manufactured in the Union of South Africa and to remove certain other explosives from the List as no longer manufactured or used.
