WEST RIDING OF YORKSHIRE COUNTY COUNCIL (DRAINAGE) ACT, 1923.

SECTION 11.

DUNSFORTH DRAINAGE AREA. (YORKSHIRE WEST RIDING.)

In the matter of a proposed Drainage Area comprising lands situate in the Townships of Great Ouseburn, Lower Dunsforth, Marton-cum-Grafton, and Upper Dunsforth-with-Branton Green, in the West Riding of Yorkshire, and subject to the provisions of the Upper Dunsforth Inclosure Award of 1776, the Marton-cum-Grafton Inclosure Award of 1803, the Great Ouseburn Inclosure Award of 1777, and the Low Dunsforth Inclosure Award of 1809.

NOTICE is hereby given that the County Council of the West Riding of Yorkshire has, by Representation to the Minister of Agriculture and Fisheries, applied for an Order under the above Act constituting a certain district in the Townships of Great Ouseburn, Lower Dunsforth, Marton-cum-Grafton, and Upper Dunsforth-with-Branton Green, and subject to the provisions of the Upper Dunsforth Inclosure Award of 1776, the Marton-cum-Grafton Inclosure Award of 1803, the Great Ouseburn Inclosure Award of 1777, and the Low Dunsforth Inclosure Award of 1809, a Drainage Area, and that within 30 days from the 4th day of October, 1930, any owner and any occupier of any lands which it is proposed by the Representation to include in the Drainage Area (or which may be affected by the execution or carrying out of the works and operations so proposed to be executed or carried out), or any Drainage Authority, or Local Authority, who may be affected by the Order, or by the flow of water from any works proposed to be executed, may send to the Minister of Agriculture and Fisheries a statement setting out his or their objections to the proposals contained in the Representation, and a copy of any such objections shall at the same time be sent to the Clerk of the County Council.
