River. Ancholme and Winterton Beck Catchment Area.

Notice is hereby given that the Minister of Agriculture and Fisheries has prepared a map determining the extent of the River Ancholme and Winterton Beck Catchment Area, and showing that part of the channel of the river which is to be treated as the main river for the purposes of Part II of the Land Drainage Act, 1930, and the watercourses which are for those purposes to be deemed to be part of the main river coloured thereon in red.
