FIRST SCHEDULE.

An Area comprising:

In the county of the North Riding of Yorkshire.

The petty sessional divisions of Langbaurgh West, Langbaurgh North (except the parish of Eston) and Thornaby and Yarm (except the borough of Thornaby-on-Tees, and the parishes of East Rounton, Picton, Low Worsall, High Worsall, Girsby, Over Dinsdale and Yarm); the parishes of Morton, Upsall, Pinchinthorpe, Hutton Lowcross, Bilsdale Midcable, Laskill Pasture, Pockley, Bransdale West, Farndale West Side, Farndale Low Quarter, Fadmoor, Skiplam, Old Byland, Murton, Dale Town, Arden, Snilesworth, Hawnby, Bilsdale West, and Osmotherley; so much of the parishes of Wombleton, Nawton and Beadlam as lies to the north of the railway from Kirkby Moorside to Helmsley; and so much of the parishes of Helmsley and Rievaulx as lies to the north of the road from Beadlam and Norton to Scawton via Helmsley village.

SECOND SCHEDULE.

An Area comprising:-

In the county of Surrey.

The parish of Pirbright; and so much-of the parishes of Ash and Normandy, Worplesdon, Woking, Horsell and Bisley as lies within (but excluding) the following boundary namely:—

Commencing at a point where the road skirting the east side of Normandy Common leaves the main Pirbright-Farnham road, thence south-easterly along the former road to the point where it crosses the road from Farnham to Worplesdon; thence in a generally north-easterly direction along the last mentioned road via Willey Green, Clasford Common, Littlefield Common, Holly Lane, and Worplesdon village and common, and continuing in the same general direction along the road via Bonnishott Nursery and Pray Heath as far as the Southern Railway (Portsmouth direct line) just north of Worplesdon Station; thence following the railway in a northerly direction as far as Hookhill Lane; thence following the road to Bisley in a generally north-westerly direction via Hookhill Lane, Holly Bank Road, St. John's Hill Road, Kiln Bridge, Robin Hood Road, Anchor Hill, Barley Mow Lane, Church Cottage, Eden Cottages and Cobbett's Farm to its junction with Port Lane at the "Hen and Chickens" Inn, Bisley Green; thence in a north-westerly direction along the road skirting the west side of Bisley Green and continuing along the road past the "Poplars" to the point where it crosses the Chobham—Bisley parish boundary; thence following in a generally southerly direction along the western boundary of Bisley parish and the northern, western and southern boundaries of the parish of Pirbright, and continuing along the road leading through Slyfield Wood to the point where it meets the main Pirbright—Farnham road; thence southwesterly along the last mentioned road to the point of commencement.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

SUFFOLK SWINE FEVER INFECTED AREA ORDER OF 1930.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Area to which this Order applies.

1. This Order applies to the Area described in the First Schedule hereto, referred to in this Order as "the Infected Area."

Restriction on Movement of Swine into, out of, or within the Infected Area.

- 2.—(1) The movement of swine into or out of the Infected Area, or along or across any road or other highway, or by water, within the Infected Area, is prohibited except with a licence granted by an Inspector of the Local Authority in accordance with this Order. Provided that this Order shall not affect or prevent the movement of swine through the Infected Area direct by railway without avoidable delay if the animals are not untrucked within such Area.
- (2) No swine shall be permitted by the owner or person in charge thereof to stray upon any road or other highway in the Infected Area.

Markets etc., of Swine in Infected Area to be restricted to Fat Swine only.

- 3. No market, sale or exhibition of swine shall be held in any market, fairground, sale-yard or place of exhibition in the Infected Area, unless it is restricted to fat swine intended for immediate slaughter, and then only in accordance with the following conditions, namely:—
 - (a) A licence shall be obtained from the Local Authority authorising the holding of the market, sale or exhibition.
 - (b) All swine exposed at such market, sale or exhibition shall be removed therefrom direct to a slaughterhouse, and shall be accompanied by a licence granted by an Inspector of the Local Authority specifying the slaughterhouse to which the swine are to be moved.
