## LAND DRAINAGE ACT, 1930.

*River Nene Catchment Area.*

Notice is hereby given that the Minister of Agriculture and Fisheries has prepared a map determining the extent of the River Nene Catchment Area, and showing that part of the channel of the river which is to be treated as the main river for the purposes of Part II of the Land Drainage Act, 1930, and the water-courses which are for those purposes to be deemed to be part of the main river coloured thereon in red.

A copy of the map has been deposited at the offices of the County Council, Cross Street, Peterborough, for public inspection for a period of one month from the date of this notice, and may be inspected between the hours of 10 a.m. and 1 p.m. and also from 2.30 p.m. to 5 p.m. on any week-day except Saturday, when the hours of inspection will be from 10 a.m. to 1 p.m.

A copy of the map may also be inspected at the offices of the Ministry between the hours of 10 a.m. and 4.30 p.m. on any week-day and on Saturday between the hours of 9.30 a.m. and 12 noon.

Any objection to the map shall be made in writing and sent by post addressed to the Secretary, Ministry of Agriculture and Fisheries, at the address mentioned below, so as to reach that office within one month from the date of this notice.
