may be granted under the regulations hereinafter mentioned of any gratuity appertaining thereto not already paid, and also to restore a forfeited Medal, together with any such gratuity, under the conditions laid down in the regulations hereinafter mentioned.

Tenthly: It is ordained that the Medal shall be awarded under such regulations as to grant, forfeiture, restoration, and other matters, in amplification of these Our rules and ordinances as may, with Our approval signified through one of Our Principal Secretaries of State, be issued from time to time by Our Army Council in regard to Our Regular Army or by the Governors-General, Governors or Officers administering the Government as the case may be, in regard to the Permanent Forces of Our respective Dominions, Colonies, or territories under Our protection, or by Our Viceroy in regard to Our Indian Army.

Lastly: We reserve to Ourself, Our Heirs and Successors, full power of annulling, altering, abrogating, augmenting, interpreting, or dispensing with these rules and ordinances, or any part thereof, by a notification under Our Sign Manual.

The Warrant of Her late Majesty Queen Victoria dated the 31st day of May, 1895, in so far as it relates to the grant of medals for long service, is hereby cancelled.
