remain the property of the Company whether it be fixed to any property or not and to make provision as to the authentication and service of notices by the Company; the inclusion of several sums in one summons and the recovery of demands and of penalties.

To authorise the Company and any local authority, company or person to enter into and carry into effect agreements and arrangements as to the supply to or by the Company of gas in bulk.

The Order will vary or extinguish all rights and privileges which would impede or interfere with its purposes and confer other rights and privileges.

To repeal alter or amend all or any of the provisions of the Alnwick Gas Act 1881 and the Alnwick Gas (Charges) Order 1922 and any other Act or Order relating to the Company or their undertaking.

To incorporate with the Order, with or without modification, or to render inapplicable all or some of the provisions of the Gasworks Clauses Act 1847, the Gasworks Clauses Act 1871, and the Companies Clauses Acts 1845 and 1863.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W. 1, and despatched on or before the 20th day of November, 1930.

Any objection shall state :---

(a) The specific grounds of objection; and (b) The omissions, additions or modifications asked for.
