AGRICULTURAL WAGES (REGULATION) ACT, 1924.

Whereas the Agricultural Wages Committee for the area comprising the administrative county of the West Riding of Yorkshire, which, for the purposes of the Agricultural Wages (Regulation) Act, 1924, shall be deemed to include the cities and county boroughs of Bradford, Leeds, Sheffield, Wakefield and York, and the county boroughs of Barnsley, Dewsbury, Doncaster, Halifax, Huddersfield

and Rotherham, have, in pursuance of the above Act, duly fixed minimum and overtime rates of wages for workers employed in agriculture for time work in that area, and the said rates are set out in the Schedule to this Order. Now the Agricultural Wages Board, in pursuance of the said Act, and for the purpose of carrying out the decision of the said Committee, hereby order that the provisions contained in the Schedule to this Order shall become effective from the 24th November, 1930.

SCHEDULE.

1. *Male Workers (living in).*

(a) The wages payable for employment of male workers living in shall be not less than wages at the following minimum rates:—

(i) Workers who are wholly or mainly engaged in one of the following classes:—

(b) The value of board and lodging as defined by the Committee is to be deducted from the above amounts.

(c) Where under his contract of employment, a worker is entitled to and takes a week's holiday, he shall receive a sum of 15s. in lieu of his board and lodging during that week.

(d) The expression "workers living in" means workers who receive as part of their remuneration under their contracts of employment board and lodging provided by the employer either in his own house or in that of one of his employees.

2. *Waggoners and other Horsemen, Beastmen and Shepherds, not covered by Clause 1 above.*

The wages payable for employment of male workers employed wholly or mainly as waggoners or other horsemen (i.e. third and fourth lads), beastmen (including assistant beast lads)

or shepherds not covered by Clause 1 above shall be not less than wages at the following minimum rates:—

3. *Other Male Workers.*

Except as provided in Clauses 1, 2 and 6 hereof the wages payable for employment of
