the Benefice in substitution for such yearly sum or stipend or for such part thereof our liability for the payment of such yearly sum or stipend or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine. Provided also that such yearly sum or stipend is granted upon and is payable only subject to satisfaction of the conditions (if any) stated with reference thereto at the foot of the said Schedule and is in lieu of and in substitution for the temporary grant hitherto payable out of our Common Fund of the amount stated in the fifth column of the said Schedule which will cease to be payable as from the date stated in the sixth column of the said Schedule.
