# Regulations applicable to the Animals on Landing.

4.—(1) The animals on being landed, shall forthwith be moved under the supervision of an Inspector of the Ministry of Agriculture and Fisheries from the quay to the premises described in the Second Schedule hereto, and shall be there detained for a period of twentyeight days. During the said period the animals shall be kept separate from all other animals, and no other animals shall be moved into such premises.

(2) The animals shall not be removed from the premises described in the Second Schedule hereto otherwise than under the authority of the licence from an Inspector of the Ministry required under Article 3 (1) (Fifth) of the Foreign Animals (Quarantine) Order of 1896.

(3) A copy of every licence authorising the movement of any animal described in the First Schedule hereto shall be forwarded to the Ministry by the Inspector who grants the licence.
