

At the Court at *Buckingham Palace*, the 27th day of *October*, 1930.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 13th day of September, 1930 (C.W. 7499/30), in the words following, viz. :—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as

are from time to time directed by Order in Council:

"And whereas by Order in Council bearing date the 13th day of July, 1928, revised regulations were laid down to govern the qualification of Officers of Your Majesty's Navy and Royal Marines as Interpreters in certain modern foreign languages:

"And whereas we consider it desirable to modify the regulations relating to qualification as Interpreter in Russian:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to approve the amendment of Schedule II to the Order in Council above referred to in the manner shown in the Schedule annexed hereto.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in the proposal.

SCHEDULE.

"The particulars relating to Russian in Schedule II to the Order in Council dated 13th July, 1928, are hereby cancelled and the following substituted:—

* The duration of appointment abroad will be decided by the Admiralty on the progress made by the candidate in his preliminary studies.

Officers appointed for nine months' study abroad who qualify in the lower standard only will receive a gratuity of £75."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 30th day of August, 1930, (G.H.), in the words following, viz. :—

"Whereas by Section 20 of the Greenwich Hospital Act, 1865, it is enacted, *inter alia*, that the Admiralty shall, from time to time, continue or appoint such Officers, Clerks, and Servants for the purposes of the Hospital and Schools as seem fit, and may (subject to the approval of Your Majesty in Council) fix the salaries of such Officers and Clerks:

"And whereas by Section 8 of the Greenwich Hospital Act, 1872, it is enacted that the provisions of Section 20 of the Greenwich Hospital Act, 1865, so far as the same relate to salaries shall extend to pecuniary benefits of any kind:

"And whereas by Your Majesty's Order in Council dated the 4th November, 1925, a pen-

sion at the rate of £217 17s. 4d. a year was granted from the funds of Greenwich Hospital to Mr. R. J. Glinn, a former Assistant Master in the Royal Hospital School, Greenwich:

"And whereas this pension requires a slight amendment in respect of the sums contributed by Mr. Glinn towards a deferred annuity fund:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the payment from the funds of Greenwich Hospital of a further pension to Mr. R. J. Glinn at the rate of Fifteen pounds, fifteen shillings and four pence (£15 15s. 4d.) per annum as from the 18th March, 1930."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.
