

the junction of Rainsford Road with Rainsford Lane, and extending thence south westward along the middle of Rainsford Lane for a distance of 25 chains or thereabouts to the point where it is crossed by the boundary which divides the said Parish of Chelmsford from a detached portion of the Parish of Widford, in the said County and Diocese, and extending thence north westward along such boundary and along the boundary which divides the said Parish of Chelmsford from the said Parish of Writtle for a distance in all of 36 chains or thereabouts to the point where the last mentioned boundary crosses the middle of the footpath leading from Admiral's Park to Lowford Lane, and extending thence westward along the middle of the said footpath for a distance of 19½ chains or thereabouts to its junction with the roadway leading from the Rainsford End Brick Works to Roxwell Road, and extending thence northward along the middle of the said roadway for a distance of 10½ chains or thereabouts to its junction with Roxwell Road, and extending thence westward along the middle of Roxwell Road for a distance of 4 chains or thereabouts to its junction with the road leading past Writtle Wick to Chignall, and extending thence northward along the middle of the last mentioned road for a distance of 40 chains or thereabouts to its junction with the roadway leading to College Farm, and extending thence eastward along the middle of such roadway for a distance of 30 chains or thereabouts to a point opposite to the middle of the footpath leading to the road called Brownings Avenue, and extending thence eastward to and along the middle of the said footpath for a distance of 16 chains or thereabouts to the boundary which divides the said Parish of Writtle from the said Parish of Chelmsford, and extending thence first northward along the last mentioned boundary and then eastward along the boundary which divides the said Parish of Broomfield from the said Parish of Chelmsford for a distance in all of 23 chains or thereabouts to the point where the last mentioned boundary diverges southward along the fence forming the western boundary of the close numbered 14 upon the Ordnance Survey Map of the Civil Parish of Broomfield published in the year 1921 on the scale of 25 inches to a mile and also upon the map or plan annexed to this Scheme, and extending thence eastward in a straight line for a distance of 11 chains or thereabouts to a point in the middle of the western end of Pottery Lane, and extending thence eastward along the middle of Pottery Lane for a distance of 7½ chains or thereabouts to its junction with Broomfield Road, and extending thence northward along the middle of Broomfield Road for a distance of 6 yards or thereabouts to a point opposite to the western end of the fence forming the boundary between the premises attached to Broomfield Lodge and the close numbered 11 upon the above mentioned maps, and extending thence eastward to and along the fences forming the northern boundaries of the said close numbered 11 and the closes numbered 10 and 9 upon the said maps for a distance of 25½ chains or thereabouts to the point where the last mentioned fence reaches the western bank of the River Chelmer, and extending thence eastward in a straight line for a distance of 7 yards or there-

abouts to a point in the middle of the River Chelmer upon the boundary which divides the Parish of Springfield, in the said County and Diocese, from the said Parish of Broomfield and extending thence first south eastward and then in various directions along such boundary (thereby following the middle of the River Chelmer) for a distance of 28 chains or thereabouts to the point where it meets the boundary which divides the said Parish of Chelmsford from the said Parish of Broomfield and extending thence first north westward and then in various directions along the last mentioned boundary for a distance of 32 chains or thereabouts to the point where it crosses the middle of Broomfield Road and extending thence southward along the middle of Broomfield Road for a distance of 27 chains or thereabouts to a point opposite to the eastern end of the wall or fence forming the northern boundary of the premises attached to the house known as Westfield, and extending thence first westward to such wall or fence and then first westward then southward and then eastward along the walls or fences forming the northern western and southern boundaries of the said premises for a distance in all of 15 chains or thereabouts to the wall or fence forming the western boundary of the premises attached to the Edward VI Grammar School, and extending thence first southward and then eastward along the walls or fences forming the western and southern boundaries of the last mentioned premises for a distance in all of 7½ chains or thereabouts to the wall or fence forming the boundary which separates the houses and premises situate in the road called Cedar Avenue from the house and premises known as Coval Lodge, and extending thence southward along the last mentioned wall or fence for a distance of 9½ chains or thereabouts to the point where such wall or fence reaches the northern side of Rainsford Road, and extending thence first southward to and then north westward along the middle of Rainsford Road for a distance in all of 3 chains or thereabouts to its junction with Rainsford Lane, at which point the said imaginary line commenced."

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Patrons and to the Incumbents of the Cures out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Chelmsford.
